### Purpose of the role

#### **Objectives**

- Responsible for assessing and managing a full caseload of patients providing specialist treatment, management and therapy services for adults with tinnitus, hyperacusis, hearing loss (including profound), associated communication difficulties and obscure auditory processing disorders
- Responsible for all technical work within the caseload which will include hearing assessments,
  middle ear function tests and hearing aid services to all adult patients
- To deliver treatments including neuromodulation, sound therapy and other medical devices and treatments in line with best practise guidelines
- To work within the policies and procedures for a safe and effective operation of the clinic in Harley Street, London, and elsewhere in London as may be agreed from time to time
- To promote the company's business within the clinic catchment area
- To represent the company as an expert in tinnitus treatment and management when required
- To support the network of ENT consultants, GP's and other health care professionals within the Marylebone Medical Village and its referral network which provides patients to the clinic
- Responsible for running occasional education sessions on tinnitus and adult audiology treatments for both public and health care professionals in London
- To deliver against key performance indicators such as conversion %, sales and client satisfaction
- To contribute to the Company's body of knowledge in tinnitus, hyperacusis and other related hearing disorders through outcome reporting, participation in studies and showing initiative in treatment development
